Invitation to Comment on RSPO Initial Certification Audit of Kretam Holdings Berhad, Syarikat Kretam Mill Sdn Bhd - Silimpopon Certification Unit

Kretam Holdings Berhad (KHB) was incorporated on 4 February 1988 and listed on the Main Board of Bursa Malaysia Securities Berhad on 18 January 1989. KHB has been a member of the RSPO since 16 September 2015 and has mature plantations in Sandakan and Lahad Datu, Sabah. The principal activities of KHB Group are:

- a) Oil palm plantation
- b) Production and sale of:
 - i) Oil palm products
 - ii) Refined palm oil products
 - iii) Processed palm oil
 - iv) Fertilizers
- c) Investment holding
