## Invitation to Comment on RSPO Recertification Audit of Sime Darby Plantation Berhad - Strategic Operating Unit (SOU) 30, Merotai

Sime Darby Plantation Berhad has commissioned SIRIM QAS International Sdn. Bhd. for the assessment and certification of its certification units against Malaysia National Interpretation of the RSPO Principles and Criteria for the Production of Sustainable Palm Oil 2018 (MYNI 2019).

RSPO was established in 2004 with the objective of promoting the production and use of sustainable palm oil. RSPO certification will enable oil palm growers and palm oil millers to claim that their product is produced sustainably. Among the requirements to market the claim are:

The followings are information on Sime Darby Plantation Berhad - Strategic Operating Unit (SOU) 30, Merotai (Membership Number: 1-0008-04-000-00 / RSPO PalmTrace ID: RSPO\_PO1000000064) and SIRIM QAS International Sdn. Bhd.:

Sime Darby Plantation Berhad has applied to SIRIM QAS International Sdn. Bhd. for RSPO certification of 10 out of its 67 certification units.

Sime Darby Plantation Sdn. Bhd. owns 237 oil palm estates and 67 palm oil mills in Peninsular Malaysia, Sabah & Sarawak in Malaysia and in Kalimantan, Sumatera, Sulawesi in Indonesia, Papua New Guinea and Solomon Island. Currently, Sime Darby Plantation Sdn. Bhd. oversees a plantation are of 312, 578 hectares in Malaysia, 202,936 hectares in Indonesia, and 105,930ha in Papua New Guinea and Solomon Islands.
