- No more certification and importation of 3G only equipment and 4G equipment without Voice over LTE (VoLTE) from 1st January 2021.
- Accelerate VoLTE provisioning by Mobile Network Operators (MNOs) & adoption of VoLTE service by the customers.

Special Working Group on VoLTE Testing was established comprises of MCMC, Service Providers, SIRIM and mobile phone manufacturers to accelerate the 3G sunset strategies.

Here's an update on what SIRIM have been doing since the announcement of JENDELA

13th Oct & 6th Nov 2020

Announcement made in eComM to inform all our certificate holders and customers on the Certification updates pursuant to 3G network sunset.

1st Jan 2021

- Submission of compliance Approval for 3G only equipment in eComM and certificate of Approval (CoA) applications are no longer allowed
- 4G equipment which capable of making calls is now mandatory to support VoLTE.

25th Jan 2021 - current

SIRIM as part of working group member for Fixed and Wireless Terminal Working Group (FWT WG) is now in the midst of revising MCMC MTSFB TC T015 to suite the latest VoLTE requirements.

25th Feb 2021

Minimum test [parameter](#) for VoLTE was published in eComm to assist the industry with the VoLTE certification requirement and will make effective and mandatory from 1 July 2021.

10th Mac Mar 2021

SIRIM has shared the FAQ* for 3G network sunset published by JENDELA in eComm to provide information on frequent questions or concerns from public.

June 2021 and beyond

SIRIM is committed to continuously deliver outstanding support and information to MCMC and the industry inline with the JENDELA goal which is to improve existing 4G network to pave way for the upcoming 5G network.
