Dear Stakeholder,

This is to inform that the above Management Unit under the Parent Company Wilmar International Limited with RSPO membership number 2-0017-05-000-00 has appointed SIRIM QAS International Sdn. Bhd. to conduct the Recertification Audit at Ribubonus Palm Oil Mill and its supply base, located at Sandakan, Sabah, Malaysia. The audit will be conducted from 8 June 2021 to 11 June 2021 against the requirements of:

Malaysia National Interpretation (MYNI) 2019 of RSPO Principles and Criteria 2018 for the Production of Sustainable Palm Oil

Wilmar is one of the world's largest oil palm plantation owners with a total planted area of 230,409 hectares (ha) as at 31 December 2018, of which about 67% is in Indonesia, 25% in East Malaysia and 8% in Africa. In Indonesia, our plantations are located in Sumatra, West Kalimantan and Central Kalimantan (southern region) while in Malaysia, they are located in the states of Sabah and Sarawak.

Apart from plantations, Wilmar also owns palm oil mills to process fruits from our own and surrounding plantations. The key products of oil palm cultivation and milling are crude palm oil and palm kernel which are mostly supplied to their Tropical Oils Manufacturing business.
