


Introduction

The importation of all waste paper to Malaysia is subjected to the issuance of a **Certificate of Approval (COA)** by SIRIM (to be gazetted under Customs (Prohibition of Imports (Amendment) Order 2021)

Objectives:

- To provide guidance in relation to the importation and inspection of waste paper into Malaysia.
- To lay down the requirements for the issuance of the COA
- To inform on the criteria requirements of imported waste paper



APPLICABLE TARIFF CODES

- i. HS 4707.10: Unbleached kraft paper or paperboard or corrugated paper or paperboard
- ii. HS 4707.20: Other paper or paperboard made mainly of bleached chemical pulp, not coloured in the mass
- iii. HS 4707.30: Paper or paperboard made mainly of mechanical pulp (for example, newspapers, journals and similar printed matter)

The waste paper of tariff code **HS 4707.90** (Other, including unsorted waste and scrap) is **not allowed** to be imported into Malaysia.


