Dear Sir/ Madam,

Extension of Transition Period for Chain of Custody Related Standards

Reference is made to our earlier letter to you dated 22 June 2020 regarding the above matter.

- 2. MTCC wishes to inform you that PEFC Council has granted a further 6-month extension of the transition period to all PEFC Chain of Custody related standards i.e. PEFC ST 2001:2020, PEFC ST 2002:2020 and PEFC ST 2003:2020 from 14 February 2022 to 14 August 2022.
- 3. This extension would provide additional time for CoC certificate holders to align their procedures with the requirements as stipulated in the 2020 versions of the standards, as well as for the certification bodies to obtain accreditation and update their procedures on the use of the new standards.
- 4. In relation to the above, please take note that after 13 August 2022, all PEFC CoC audit will be conducted against PEFC ST 2001:2020 and PEFC ST 2002:2020 standards. As you are aware, in the interim process, there will still be PEFC CoC certificates issued against PEFC ST 2001:2008 and PEFC ST 2002:2013. And it is mandated that all these PEFC certificates shall comply with the requirements of the PEFC 2020 standards by 14 August 2023.
