- 6. Preparation of draft Audit Report describing the audit process, findings and recommendation on certification;

- 8. Peer review of draft Audit Report by two independent peer reviewers;
- 9. Submission of final Audit Report to the Head of Food, Agriculture and Forestry Section of SIRIM QAS International; and
- 10. Disclosure of public summary, if certification is granted to the FMU.
