This audit will assess the forest management practices of Kedah FMU against the requirements of the *Malaysian Criteria and Indicators for Sustainable Forest Management* (MC&I SFM) standard related to economic, social and environmental aspects. 6. Preparation of draft Audit Report describing the audit process, findings and recommendation on certification;
7. Peer review of draft Audit Report by two independent peer reviewers;
