This audit will assess the forest management practices of Lana FPMU against the requirements of the *Malaysian Criteria and Indicators for Sustainable Forest Management (MC&I SFM)* standard related to economic, social and environmental aspects. - 3. Field audit on representative samples of forest sites and operation within the FPMU;
- 4. Stakeholder consultation involving private interviews, discussions or small group meetings with local communities surrounding the FPMU;
- 5. Closing Meeting with representative of FPMU to present preliminary findings of the audit;
- 6. Preparation of draft Audit Report describing the audit process, findings and recommendation on certification;



- 7. Peer review of draft Audit Report by two independent peer reviewers;
- 8. Submission of final Audit Report to the Head of Food, Agriculture and Forestry Section of SIRIM QAS International; and
- 9. Disclosure of public summary, if certification is granted to the FPMU.
