This is to inform that SIRIM QAS International Sdn. Bhd. (SIRIM QAS International) will conduct stage 2 audit for forest management certification on Penuan-Lebuwai FMU managed by Jaya Tiasa Holdings Berhad.

SIRIM QAS International is a certification body accredited to the Department of Standards Malaysia. This audit will assess the forest management practices of Penuan-Lebuwai FMU against the requirements of the *Malaysian Criteria and Indicators for Sustainable Forest Management (MC&I SFM)* standard related to economic, social and environmental aspects. 5. Closing Meeting with representative of FMU to present preliminary findings of the audit;
6. Preparation of draft Audit Report describing the audit process, findings and recommendation on certification;
